The sectional champion and runner-up are the regional dual team qualifiers. Some champions and runners-up from the same sectional are assigned to the same regional dual and some are not depending on whether power can be split within a geographic area. The regional semifinal pairings place the highest ranked team at a site against the lowest ranked team and the second highest ranked team against the second lowest ranked team, according to the mid-January IWCOA Dual Team Rankings. While the IWCOA posts rankings for the top 16 teams, many more teams received votes and all votes are used when pairing teams at a given site.

Each regional meet is a double dual. The teams winning in the first round of the regional double dual will compete in the finals, with the winning team qualifying for the state dual team tournament at Wells Fargo Arena in Des Moines.
